

**Village of Cambria Board Meeting
Minutes for March 3, 2026**

Call to Order: Attorney Webb Smith called the meeting to order, and to Elect and Appoint an Interim Chair tonight and an Interim Municipal Clerk for the meeting.

Marshall Brown made a motion for Mike Ren to be Interim Chair, and Mike Ren declined to accept. He then made a motion for Robby Chitwood to be an Interim Chair, and Mark Phillips 2nd the motion. Roll call: All agreed, except Marshall Brown and Robin McFarlin voted NO. Motion carried.

Robby Nominated Theresia Money for Interim Municipal Clerk, and Mike Ren 2nd. Roll Call and All Yes.

Approve the Minutes for February 3, 2026 Robin made a motion, and Mike 2nd the motion. Rollcall, and all in favor of the motion.

Trustees reviewed the Disbursements paid out to vendors and employees. Robin made a motion to authorize the disbursements paid in the amount of the agenda from February 3, 2026. Rollcall, and all in favor of the motion.

Robin made a motion for Elite Pest Control to service Village Buildings another year. Mark 2nd. Rollcall, All Approved. Motion Carried.

Robby made a motion for Theresia Money for Full-Time Water Clerk. Mike 2nd. Rollcall, All yes except Marshall, NO. Motion Carried.

The Trustees agreed to Table the Municipal Grocery retailers' tax, so they could research.

Robin made a motion for The Village to Sponsorship of 987 Newsletter. Mike 2nd. Rollcall All Yes. Motion Carried.

Marshall made a motion to Livestream Board Meetings & Purchase equipment. Robin 2nd. Rollcall, Mark-NO, Mike-NO, Robby-NO. Motion did not carry.

Marshall made a motion for the Fire Department to do the programming on the Sign at Fire Station. Robin 2nd. Rollcall, and All Yes. Motion Carried.

The Trustees Tabled Outside contracting for Municipal Mowing.

The Trustees Tabled Summer Youth Program until speaking with Bruce.

The Trustees Tabled Sidewalk partnership with J.A. Logan until speaking with Bruce.

Jimmy Emery and Bill Hays said they would split the cost and replace the Flag at Park and Memorial Park.

Marshall made a motion to get a quote for a New Sign at the Park vs maintenance. Mike 2nd Rollcall, All Yes. Motion Carried.

Robby made a motion for an Engineer to look over safety concerns of cafeteria & building. Marshall 2nd. Rollcall, All Yes, except Mike NO. Motion Carried.

Robby made a motion to appoint Officer E. Miller to full-time employment. Mark 2nd. Rollcall, Mike-Yes Robin-NO, Marshall-NO. Motion Carried.

The Trustees Tabled compensating Officer E. Miller \$120.00 net pay vs. \$100 for not utilizing the Village insurance, he will get with Office Clerk and go over options.

Robby motioned to have the Chief Boss offer one applicant for training for Full-Time Police Academy with compensation of an hourly rate during academy attendance. Mike 2nd. Rollcall, All YES. Motion Carried.

The Trustees Tabled Compensation of Chief Boss working overtime and being compensated for that time, while Robby and Chief Boss discussed the Dollar Amount of the 29 hours overtime Retroactive pay.

The Trustees Tabled to Review Chief Boss' recommendation regarding termination of L. Prince, Due to L. Prince resignation by email on 3/3/26.
